In 2013 he became Chief Financial Officer of iBasis in the United States, a position he held until the beginning of 2019. Subsequently he returned to the Netherlands where he held the position of Executive Vice President Group Control at Eneco Groep. Jörg holds a Master of Science in International Business, Corporate Finance & Management of the Maastricht University and is a graduate of the Advanced Management Program at Harvard Business School in Boston, MA.

At CM.com's Annual General Meeting of shareholders to be held at 30 April 2020 Jörg de Graaf will be nominated for appointment as Statutory Director. Subsequently Jeroen van Glabbeek (CEO), Gilbert Gooijers (COO) and Jörg de Graaf (CFO) will jointly form the Management Board of CM.com. Jörg will succeed Judith Wouters (CFO a.i.), who will remain with the company as Head of Finance.
